



**WAIVER, RELEASE OF LIABILITY,  
ASSUMPTION OF RISK, AND INDEMNITY  
AGREEMENT FOR  
Paintball at CowTown Range**



In consideration of Cowtown Range, LLC and Westward Ho Adventures, LLC (collectively hereinafter “Cowtown”) furnishing services and/or equipment to enable me to participate in the **SPORT OF PAINTBALL** (the “Activity”) I acknowledge that I understand the nature of the Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity; and that if I believe conditions are unsafe I will immediately discontinue participating in the Activity; and I agree as follows:

I fully understand and acknowledge that this Activity involves risks of serious bodily injury, including, but not limited to, blindness, heat stroke, heart attack, fractures, possible transmission of disease/pandemic viruses or strains, permanent disability, paralysis and death, or other ailments/injuries which may be caused by forces of nature, my own actions/inactions, or the actions/inactions of others participating in the Activity. I acknowledge and accept the conditions in which the Activity takes place, the equipment provided for the Activity, and acknowledge that there may be other risks either not known to me or not readily foreseeable at this time. I fully accept and assume all risks and all responsibility for losses, costs and damages I may incur as a result of my participation in the Activity.

Further, I hereby release, discharge, and covenant to not sue Cowtown, its respective administrators, directors, agents, officers, volunteers, employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence of Cowtown or the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against Cowtown or any of the Releasees, I will indemnify, save and hold harmless Cowtown and each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this **WAIVER, RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**, and I understand that I may have given up substantial rights by signing it, and have signed it freely and without any inducement and assurance of any nature and intend it be a complete and unconditional release of all liability of Cowtown and the Releasees for personal injury, property damage, or wrongful death caused by negligence or any other cause, to the greatest extent allowed by law, and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
